

FORMULAIRE D'INFORMATION ET DE DROIT A L'IMAGE

(hereafter referred to as « the Passenger »)

for the **Air Zero G** flight on on board the Airbus A310 ZERO-G.

The Passenger is informed that the Air Zero G flight is classified in the category « Sensation flight » as defined on chapter 1 of the Order of July 24, 1991, on conditions of use of civil aircraft in General Aviation. It does not represent a public air transportation activity as defined by law (Transport Code).

The aircraft has a temporary permit to fly delivered by the French Directorate-General of Civil Aviation, differing from the standard Certificate of Airworthiness (CofA) issued for public transportation aircraft. The Passenger accepts the fact that the flight complies with the specific requirements of the « Sensation Flight » regulation and does not comply with safety standards defined for public air transportation. Novespace has performed safety studies and has entrusted the maintenance of the aircraft to a recognized organization (Sabena technics). However, the Passenger will note the fact that the qualification process of the A310 ZERO-G has not been as in-depth as the certification of public transportation aircraft, and that there are additional risks related to the difficulty in controlling movements when under microgravity **and to the absence of automatic oxygen system in the experimentation area.**

Taking part in such a flight may cause the cancellation of guarantees for loans or insurance policies taken out on a personal or professional basis (real estate, insurance against death, invalidity...). The Passenger notes the recommendation made to him to check that his insurance policies do not include clauses making them null and void in the case of taking part in a flight on board aircraft without a standard certificate of airworthiness. The Passenger declares that he/she has understood that, in this case, he will not benefit from these insurance policies.

The Passenger notes the fact that Novespace has taken out an individual insurance for him, covering physical injuries sustained during the flight, with an upper limit of compensation of 300 000 euros per person. The Passenger notes the fact that the indemnity that Novespace / air Zero G could owe him in case of injury could in no case exceed the sum of 300 000 euros. The Passenger notes the opportunity offered to him to subscribe on his own a complementary insurance, which can increase the limit of liability by a sum up to 350 000 euros, provided he pays a premium on his own. The Passenger declares he was informed about the steps to take the complementary insurance on his own.

The Passenger agrees that he will comply with the flight regulations and that he will obey in to crew orders under any circumstances.

The Passenger authorizes Novespace / air Zero G to photography and/or film him in Novespace facilities and aircraft and to use the passenger image for any purpose of promotion and communication, including publicity and commercial communication. The Passenger will not be allowed to sell or use the pictures or film taken in Novespace facilities or on board the aircraft for commercial or advertising purpose.
